- WBM Partnership, LP ("WBM") directly owns 8,353,867 shares of Common Stock. WBM is controlled by Mr. Mosing, in his capacity as managing member of WBM's general partner. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by WBM, except to the extent of his pecuniary interest therein.

5. The 39,911,994 shares reported are owned directly by Mosing Holdings, LLC, as of December 4, 2017. As a result of the Voting Agreement, dated July 22, 2013, by and among Ginsoma Family C.V., FWW B.V., Mosing Holdings, LLC and the other parties thereto, Mr. Mosing may be deemed to beneficially own shares of Common Stock owned by Mosing Holdings, LLC. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by Mosing Holdings, LLC, except to the extent of his pecuniary interest therein.
