**Explanation of Responses:**

- Donald Keith Mosing Family Partnership, Ltd ("DKM PL") made a distribution of 1,097,858 shares of Frank's International N.V.'s common stock, par value Euro 0.01 per share (the "Common Stock") to DKM PL's limited partners.
- As of September 26, 2019, the DKM PL directly owns 5,273,062 shares of Common Stock. DKM PL is controlled by Donald Keith Mosing, in his capacity as its general partner and trustee of its other general partner, Donald Keith Mosing Revocable Trust.
- The 1,100,462 shares reported are owned directly by the 2015 Mosing Family Delaware Trust f/b/o Keith Mosing, of which Donald Keith Mosing is the investment advisor. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.
- The 223,991 shares reported are owned directly by the By-Pass Corporate Stock Trust u/l/w Janice P. Mosing f/b/o Donald Keith Mosing, of which Donald Keith Mosing is the trustee. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.
